Entry visa	Single and multi entry up to one year	660.00

The following are exempted from paying a fee:

- Children under the age of six years.
- Schoolchildren, students in higher education, research students and their accompanying teachers – on condition that the purpose of the trip is studies or education.
- Researchers – on condition that the purpose of the trip is scientific research.
- Government official visits with a Note Verbal and Diplomatic or Official passport.
- Official visits from a South African Municipality invited by a Swedish Municipality.
- SIDA funded projects
- Relatives of EEA nationals (citizens of the EU, Norway, Iceland and Liechtenstein) or Swiss nationals do not need to pay a fee for their visa applications if they are going to travel together with that relative or meet in connection with the journey. The applicant must present a certificate, which confirms marriage or relationship. **Please note however, that relatives of Swedish nationals must pay a fee to apply for a visa.**
- The following persons are classified as relatives:
 - husband, wife, co-habitee *
 - registered partner
 - a child under the age of 21 years or an older child who is dependent on his/her parents for his/her keep
 - parents who are financially dependent on children in Sweden

** Does not apply to persons co-habiting with Swiss citizens.*

Exceptions: Not everyone has to pay an application fee. The following categories are not required to pay an application fee for a residence and/or work permit:

- Spouses, registered domestic partners, or de facto spouses and children under 18 who are applying for a residence permit based on a family connection to a foreign citizen who has been granted a residence permit in Sweden as a person in need of protection or on the basis of particularly distressing circumstances.
- Family members of EU/EEA citizens.
- EU/EEA citizens applying for residence permits.
- Citizens of Switzerland and their family members.
- Citizens of Japan.
- Students at the World Maritime University in Malmö.
- Students who have been awarded scholarships by SIDA or another Swedish organisation or international organisation such as the EU or UNICEF.

- **Office hours are Monday to Friday 09h00 – 12h00, Wednesday closed (no applications are accepted). After 13h00 hrs on Fridays the Embassy will remain closed until following Monday**
- **Passports NOT picked up during office hours on the designated date of collection will be entirely the responsibility of the applicant or representative**
- **The Embassy does not accept Cash**
- **Only completed applications including proof of payment will be accepted**
- **Applications by mail will NOT be accepted**
- **Applications must be submitted in person or through a representative**
- **Visa processing time is normally 5 working days excluding Wednesdays**
- **All visa fee applications are accepted on a non-refundable basis**
