

Schengen Visa requirements

Business Visa/ Conference Visa

- Passport with 3 months left before expiry upon leaving the Schengen area, UK residence permit with minimum 1 month left before expiry upon leaving the Schengen area, originals AND photocopies
- Schengen Application form filled in completely, signed in three places and dated
- Appendix A filled in, signed, and dated
- 3 months bank statement showing names, address, and transactions, unless the employer letter confirms that they will take care of all costs, accommodation, and expenses
- Invitation from Swedish host/ University/Conference confirmation
- Valid travel insurance including repatriation
- Recent letter of employment/University letter

Tourist Visa

- Passport 3 months left before expiry upon leaving the Schengen area & UK residence permit with minimum 1 month left before expiry upon leaving the Schengen area, original AND photocopies
- Schengen Application form filled in completely, signed in three places and dated
- Evidence of sufficient funds (min 60 Euros per day)
- Hotel and flight booking
- Valid travel insurance including repatriation
- Recent letter of employment/Recent letter from university/Recent school letter/Recent benefit letter/Recent pension letter

Visa to Visit Family & Friends

- Passport with 3 months left before expiry upon leaving the Schengen area & UK residence permit minimum 1 month left before expiry upon leaving the Schengen, originals AND photocopies
- Schengen Application form filled in completely, signed in three places and dated
- Last three months bank statements showing names, address, and transactions
- Evidence of sufficient funds (min 45 Euros per day plus monies to cover return flight if host is sponsoring the stay)
- Official Invitation Form from Referee - Appendix E and Person Bevis (Personal ID from the Swedish Tax Office)
- Valid travel insurance including repatriation

Recent letter of employment/ Recent letter from University/Recent benefit letter/Recent pension

Visa requirement for non-EU family members of EU citizens living in UK

- Passport minimum 3 months left before expiry upon leaving the Schengen area & UK permit with minimum 1 month left before expiry upon leaving the Schengen area, original AND photocopies.
- Schengen Application form filled in, signed in three places, and dated
- EU /EEA spouse/dependant's original passport
- EU/EEA spouse/dependent's's birth /marriage certificate
- Holders of a Residence Documentation Sticker/Card issued by UK to non-EU family members of EU citizens living in UK will no longer be exempt from the visa requirement and will have to apply for an entry visa. The full documentation according to the Visa Code. Visa fee required
- Family Members who have acquired Pre-Settlement/Settlement status require a visa. The full documentation according to the Visa Code required. Visa fee required
- However, the non-EU family member will continue to benefit from the Freedom of Movement Directive 2004 and has the right to be issued a visa free of charge and only requires to present their valid passport and proof of family ties and a proof that the EU citizen is (or will be) exercising free movement rights in Sweden
- When travelling to the EU Member State of which the EU citizen is a national, the Visa Code must be followed, and full documentations required. Visa fee required

Visa Requirements for Non-EU family members of UK nationals living in the UK

- Holders of a Residence Permit based on a UK national travelling with the UK national or alone needs a visa. Full documentations according to the Visa Code required. Visa fee required
